3 Settlement Agreement Dated April 15, 2003 to the entering of a
4 Stipulated Consent Judgment.

7 respective counsel, that the following Final Judgment and Injunction is
8 entered against Defendants.

10 IT IS ORDERED, ADJUDGED, AND DECREED,
11 that:

13 1. Plaintiff and Counter-defendant Hsiao & Montano, Inc. is a
14 California corporation doing business as Odyssey Innovative Designs
15 within the County of Los Angeles, State of California.

17 2. Defendant and counter-claimant Toptone Manufacturing, Inc.,
18 Inc. is a California corporation having its principal place of business
19 at: 1830 Belcroft Avenue, City of South El Monte, County of Los Angles,
20 State of California.

22 3. Defendant and counter-claimant Crystal Wang is an individual
23 having her principal place of business at: 1830 Belcroft Avenue, City of

11 scope of the U.S. Patent, including but not limited to the following
12 products having the following model numbers that incorporate the
13 patented inventions that include Slide Members: GS 201-10 X 4; GS 201-12
14 X 4; GS 201-14 X 4; GS 201-16 X 4; GS-1400; GS-1900; GS-2014 X 4; GS-
15 2016 X 4; GS 2018 X 4; M-1400; GS-1400, and all versions thereof. The
16 term "Slide Members" is defined in the April 15, 2003 executed
17 Settlement Agreement in connection to this action.

19 7. Plaintiff and Defendants waive their respective right of appeal
20 in connection with this Stipulated Consent Judgment.

22 The parties hereby stipulate to the entry of this Judgment.


